Please be advised as follows:

- a) The Controller of your personal data is the Polish Alternative Fuels Association (PSPA) with its registered office in Warsaw and Automotodrom Brno a.s.Masarykův okruh with its registered office in 20166481 Ostrovačice, Czech Republic ("Controllers");
- b) Your personal data are processed by the Controllers in connection with your participation in an automotive event and the test drive referred to in this declaration. Your data will also be processed for the marketing of our products if you have given your consent to this above;
- c) Your personal data will not be used for purposes other than the ones for which they were originally collected;
- d) Your personal data will be provided exclusively to the employees and associates of the Controllers (including, in particular, IT companies);
- e) Your personal data will not be provided to third countries, not belonging to the European Economic Area;
- f) Your personal data will be kept until the service is provided. The retention period may be extended if the processing of the personal data is required to pursue or defend against claims.
